

Chapter 1 - Instruction to Bidders

Tenders are invited (in two parts) for "Disposal of old condemned vehicle at Institute of Forest Productivity, Ranchi on 'As is where is Basis'.

Tenders documents shall be submitted only at Institute of Forest Productivity, Ranchi. Tenderers / Firms are advised to follow the instructions provided in the 'Instructions to the Firms/Tenderer for the submission of the bids.

In case the tender form found to temper/ modified in any manner, tender will be completely rejected and EMD would be forfeited and tenderer is liable to be banned from doing business with IFP.

The tender document will be available in the office on all working days during working hours and can be obtained from Vehicle section, IFP, Ranchi on payment of Rs. 590/- in cash or by DD in favour of Director, Institute of Forest Productivity, Ranchi payable at Ranchi. The tender form / document is also available at website <https://ifp.icfre.gov.in> and <http://icfre.gov.in>. The tender form/document downloaded from the above website must include Rs. 590/- (DD, in favour of Director, Institute of Forest Productivity, Ranchi payable at Ranchi as tender fee along with the tender to be submitted).

Tender Fee

Applicant (firms /tenderer) must provide demand draft for Rs 590/- (Rupees Five hundred and ninety only) (to be purchased on or after publication date of this tender) in favour of Director, Institute of Forest Productivity, Ranchi payable at Ranchi, obtained from any Nationalized/ scheduled Bank valid for three months with their application/downloaded tenders as the cost of tender form / document. All the applicable bank charges shall be borne by the applicant and he/she shall not have any claim what so ever on this account on Government. In case of re-tendering, the firms which have submitted the DD in earlier calls will require to submit DD along with their tender application in subsequent calls also. **Tender not accompanied with the cost of tender fee are liable to be rejected.** However, public sectors undertaking / Govt. undertaking firms are exempted from the payment towards cost of tender documents on submission of the proof for exemption (copy of affidavits and credit facility certificate).

EMD Payment

Earnest Money Deposit (EMD) for an amount of Rs. 2000/- for each condemned vehicle in the form of DD in favour of Director, Institute of Forest Productivity, payable at Ranchi should be submitted along with the Technical Bid cover, **on or before 10th December 2018, 05.00 PM (Bid document submission closing Date).**

For unsuccessful tenderer EMD will be refunded immediately after finalization of the tender. EMD shall be forfeited if any tenderer withdraw their offer before finalization of the tender or fails to submit offer of acceptance within 7 days from the date of order.

Submission of Tender - The tender has to be submitted in the office in two parts i). **Technical bid** and ii). **Financial bid** as per **date/time mentioned in the document**. All the pages of bid being submitted must be signed by the bidder irrespective of nature of content of the documents. No correspondence will be entertained in this matter.

a) Technical Bid cover

The following self attested documents are to be submitted by the Tenderer / Firm in the 'Technical Bid cover'. Mention 'Technical Bid cover for the tender' on the top of the envelop to be submitted.


1. The rates shall be quoted in Indian Rupee only.
2. The quoted rates of old condemned vehicle shall remain firm throughout the tenure of the contract and no revision is permissible for any reason.

Opening of Tender

- i. Technical Bids will be opened as per date/time as mentioned in the Tender document in presence of the bidders or authorized representatives of the bidder. Bids without Earnest Money (EMD), Tender fee or documentary evidence issued by Government authorities for according exemption towards submission of EMD will be rejected.
- ii. Only authorized representatives in writing, by the respective tenderers shall be permitted to be present during the tender opening, along with the condition of only one person per participating / attending tenderers.
- iii. Representatives of a firm, who has NOT participated in the tender, shall not be permitted to be present at the time of opening of a tender.
- iv. Due date of opening financial bid shall be intimated later on only to those tenders whose bids will be found technically & commercially acceptable after scrutiny.
- v. Amendment to a tender will not be permitted once submitted.

Chapter - 2: Terms & Conditions

1. The rate shall be quoted in Financial bid format. The rates of GST applicable should be quoted. The tenderer will be required to pay the requisite GST, as applicable to govt. of Jharkhand and Govt. of India as applicable.
2. The rate may be **quoted in Indian Currency**. No rate quoted in Foreign Currency will be entertained.
3. The prices quoted must be FIRM till the completion of the process. The prices offered should be given preferably both in words and figures.
4. The tenderer / firm will have to take away the vehicles from the respective places under IFP, Ranchi as mentioned in the tender document.
5. Jurisdiction: Only the courts at Ranchi in the Jharkhand State will have the jurisdiction to deal with and decide any legal matter or dispute whatever arises out of our contract.
6. The firms must indicate their Fax No., Telephone No., Email address, PAN No. , GST No., JST/ CST No., TIN No., Aadhaar No., Excise code No., Registration No. etc (wherever applicable) on the printed letter head.
7. ALL PAGES OF TENDER DOCUMENTS / OFFER ALONG WITH ENCLOSURES SHOULD BE SIGNED WITH NAME AND DESIGNATION AND HAVE COMPANY'S SEAL.
8. Tenders erased or overwritten will be summarily rejected unless corrections are authenticated with the Tenderers signature.
9. The tender should be submitted as per the instructions given in **Tender document**.
10. Director, IFP reserves the right to reject or accept or withdraw the tender in full or part as the case may be without assigning reason thereof. Tenderer are advised to carefully note that deviation in these terms will not be entertained.
11. Decision of the Director will be final and binding on all tenderer. Regarding preference of auction, decision of committee shall be final. The committee will scrutinize all the documents while deciding the final work.



14. The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Voters Identity Card, Aadhaar card in case of individual and Registration Certificate in case of firms etc.)
15. The sold vehicle will be removed by the successful bidder(s) **within 3 days** of depositing the money at their own expenses. No assistance/transportation will be provided by IFP. Permission to take out the disposed vehicles from IFP premises will not be allowed on holidays/Saturdays and Sundays.
16. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.
17. EMD of the firms rescinding their offer, withdrawing or abrogating after submitting the Bid shall stand forfeited. Decision of IFP shall be final in this regard.
18. The Institute reserves the right to reject all or any tender in whole or part without assigning any reasons thereof.
19. EMD of unsuccessful tenderers will be returned within three weeks of the award of contract to successful party.
20. The bidder is required to reveal his full name/name of the authorized signatory of the firm/name of father, full postal address, telephone number & mobile number.
21. Tendering form should be signed in ink by the authorized signatory only. Photocopy or unsigned quotations or quotations not signed by authorized signatory shall be rejected.
22. Tendering firm shall alone be responsible for furnishing any false or wrong information and the consequences or loss thereof.
23. No Complaint whatsoever will be entertained after the tender submitted before or after the vehicle is lifted. No request for inspection after submission of tender will be accepted.
24. In the event of acceptance of tender, the successful bidder will be required to deposit full amount through **DD in favour of Director, Institute of Forest Productivity, payable at Ranchi** within **7 days** from the issue of order, failing which the sale order shall be cancelled.
25. The vehicle will be delivered only after the receipt of full payment and has to be lifted within **03 days** of completion of deal failing which ground rent at the rate of Rs.500/-per day will be charged.
26. The person authorized by bidder will be allowed to take the delivery. The bidders are required to produce documentary evidence for proof of their address.
27. The address given in the tender shall be deemed to be bidders address and correspondence sent on that address shall be considered.
28. Once the release order issued, this office will not be responsible either for safe custody or for any loss or damage to the subject vehicle.
29. The bid once accepted is not transferable to anyone. In case the bidder is a company, the name of the company should be indicated as the bidder. In such cases the person appearing for the company should have the authorization letter in a proper format issued from a competent authority of the company. Request to change the name of the bidder in the tender after submission of the tender will not be entertained.

30. Only the highest bid amount above the minimum estimated price will be accepted.
31. If highest bidder does not accept the offer of sale of vehicle for any reason whatsoever it may be, and withdraws from the bidding, second highest bid amount may be considered for sale, if accepted by the Director, IFP, Ranchi and accordingly the second highest bid amount will be considered as the highest bid amount, subject to minimum reserve price conditions. In case of any dispute, decision of Director IFP, Ranchi shall be final.
32. The Director, Institute of Forest Productivity reserves the right to reject any or all the tenders without assigning any reasons. Director, Institute of Forest Productivity also reserves the right to withdraw the said vehicle from the tender without assigning any reasons thereof.
33. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.
34. The bidders will not be allowed to withdraw their bids failing which their earnest money will be forfeited.
35. The successful bidder who takes possession would be responsible for the bona fide use of the vehicles.
