The ICFRE, an Autonomous Body of the Ministry of Environment, Forests and Climate Change, Government of India, invites applications from the eligible officers under Central/State/Public Sector Undertakings/Autonomous Bodies/Statutory organizations for filling up one post of Security Officer on (i) deputation including short term contract (ii) Re-employment of retired personnel of Armed Forces/Paramilitary Forces/Police in the Pay Scale at level 7 Pay Matrix of 7th CPC at Forest Research Institute, Dehra Dun under ICFRE.

Eligibility:

(i) By deputation/Short Term Contract Basis:

Officers of Central Government/Autonomous Bodies/Public Sector Undertaking holding analogous post in Level 7 of 7th CPC Pay Matrix

OR

Personnel of central Government/Autonomous Bodies/Public Sector Undertaking holding a post in Level 6 of 7th CPC Pay Matrix and having 5 years regular service in the grade with experience in security related matters in the organization.

(ii) Re-employment of retired personnel of Armed Forces/Paramilitary Forces/Police:

A retired/released personnel of less than 55 years of age who has served in Armed Forces/Paramilitary Forces/Police on analogous post in Level 7 of 7th CPC Pay Matrix.

OR

A retired/released personnel of less than 55 years of age and served in Armed Forces/Paramilitary Forces/Police on analogous post in Level 6 of 7th CPC Pay Matrix and having 5 years regular service in the grade.

Tenure (in case of appointment on deputation including short term contract): The tenure shall ordinarily be 3 years or till superannuation, whichever is earlier. The tenure is, however, liable to be terminable at an earlier date or extendable at the discretion of appointing authority/cadre controlling authority.

Age Limit: Not exceeding 55 years as on 30.09.2019 (in case of Re-employment of retired personnel of Armed Forces/Paramilitary Forces/Police).

GENERAL INSTRUCTION

1. Applications with complete bio-data together with a fee of Rs.500/-(Rupees Five hundred only) in the form of Demand Draft drawn in favour of **the Accounts Officer, ICFRE** should reach the office of the Secretary, Indian Council of Forestry Research and Education, P.O. New Forest, Dehradun on or before 30.09.2019.
2. Application and the envelope should be superscripted as "Application for the post of Security Officer" against Advt.No.32-71/2017-ICFRE (Security Officer). Applications incomplete in any respect shall be summarily rejected.
3. In no case the Council will be responsible for non-receipt of application or any delay in receipt thereof on any account whatsoever. No application received after the stipulated last date will be entertained under any circumstances and all the late applications will be summarily rejected.
4. The candidate must submit their application through proper channel. The concerned department/organization should enclose vigilance clearance report and Annual Confidential Reports of the officer for the last five years (2014-15 to 2018-19) while forwarding the applications of the candidates. However, an advance copy can be submitted along with the prescribed fee.
5. The Council reserves the right to relax, the qualifications/experience in case of exceptionally qualified and meritorious candidates.
6. The Council reserves the right not to fill up the vacancy advertised if the circumstances so warrant in the interest of the Council.
