CIRCULAR

The Indian Council of Forestry Research and Education is an Autonomous Council of the Ministry of Environment Forests & Climate Change, Government of India, with its Institutes at Dehradun, Jabalpur, Bangalore, Jorhat, Jodhpur, Coimbatore, Shimla, Ranchi, and Hyderabad.

The following posts in the ICFRE's Institutes and its centres are available for filling up on deputation basis at the level of Conservator of Forests (CF) from IFS officers in the pay scale of Pay Matrix Level 13A and Deputy Conservator of Forests (DCF) from IFS/SFS officers in the pay scale of Pay Matrix Level 13, Level 12 and Level 11. IFS officers who are already working in the pay scale at Level 14 of Pay Matrix may also apply for consideration to the post of Conservator of Forests and they will be eligible for pay protection as per rules. The tenure of All Indian Service Officer will be governed in accordance with the provisions under prevalent rules in this regard.

The officer on appointment on deputation to the council would get pay and allowances as per prevalent rules.
