Govt. servants applying for the above posts should forward their applications "Through proper Channel" and should enclose "No Objection Certificate" obtained (Annexure-4) from their Appointing Authority. They may send an advance copy of the application by the due date, if they so desire. The forwarding authority should ensure that in the event of selection of the official, he should be in a position to relieve / spare the official within the time specified in the offer of appointment.
- 6.
